TERMS & CONDITIONS

Please familiarize yourself with the enclosed materials to avoid service installation delays. **Your signature at the bottom of the order form indicates your understanding of all the terms and policies for your ordered service(s).** If you have any questions please call the CAJUNDOME Service Desk at 337-265-2222.

ELECTRICAL:

The CAJUNDOME/Convention Center offers 120v and 208v services in ExHall and Dome floor. Standard services are on the attached worksheet. Specialty services such as overhead power and outdoor power have limited availability due to locations and restrictions at the CAJUNDOME and Convention Center (must call for quoted pricing, availability, and locations). Power will be located in the rear of the vendor booth, distribution and cables will pass through all booths even if not requiring electricity in the booth. (This is required to get power to other booths and is part of the show, it will not be relocated for a booth holder). All equipment shall be turned off on none show times due to fire codes, for safety and save our earth (green), unless special needs for refrigerated items are needed. Electrical connections for exhibitors may plug into purchased standard outlet (1) only. It will be up to the discretion of the house electrician if equipment does not meet National Electrical Code and UL approved on equipment being used for the show is unsafe to the patrons and service will not be provided to the booth holder. None payment of electrical will be turned off until payment has been received. Electrical equipment must be properly tagged or marked as the type and/or amount of current voltage, phase, frequency, horsepower, etc. required. All single phase 208volt and three phase 208volt are bare ends only unless vendor is providing male and female plugs for equipment. Equipment and distribution provided is the property of the CAJUNDOME and is only a rental item. The CAJUNDOME is not responsible for damaged personal equipment and/or personal injury caused by the misuse of equipment.

RV PARKING and ELECTRICAL SERVICES

The CAJUNDOME/Convention Center offers RV spots with electrical hookups. RV spots with electrical hookups are located at the rear of the CAJUNDOME (RV Lot).

Payment in full must be received before parking and electrical service will be activated and must be assigned a parking number. We have a total of five (5) RV spots that are equipped with a 30amp only 120 volt receptacle and a GFI receptacle slaved of a main breaker.

RV spots are on a 1st come bases based on received payment (call for availability).

The CAJUNDOME is not a full service camp site, all black and gray water must be self-contained in the camper. CAJUNDOME HAS NO WATER OR SEWER FOR RVS. Absolutely no gray or black water will be allowed to dump on CAJUNDOME grounds, any violations will terminate rental and asked to remove RV from grounds with a clean-up fee. All trash created by the camper must be removed or will be subject to a clean-up fee. For more information or details please contact the Service Desk at 337-265-2222.

EQUIPMENT SERVICES

Orders made in advance will be guaranteed at specified time of load-in. Standard rate orders will be serviced on a first come, first serve basis. All orders will be serviced before show opens. However, any orders placed at load-in time are not guaranteed to be ready for show time. The CAJUNDOME Production Department will be contacted when these orders are placed to determine an estimated time of delivery. In the case of phone line orders for a credit card machine, each vendor is responsible for programing their own machine. The machine should be programmed to dial 9 before dialing the phone number. INTERNET SERVICES
